Alberta Health Services has not been able to provide full clarity as how to manage a private gym facility within condominium complexes.

Public gyms have had bans lifted as of June 12, 2020 and these for profit public gyms have full time staff to manage the gym facilities and disinfect equipment, etc., where as a privately owned gym facility such as Legends does not. This is where the lack of clarity is coming from.

Given that the demand from residents to reopen has been substantial, we have decided to open the facility. As such, several policies have been created so that we may safety allow your gym to open for your use.

Nonadherence to these rules/policies can and will result in closure of the gym.

As the situation evolves around Covid19, we will advise and react accordingly.

The Gym will be opening for resident use on June 22, 2020.

The men's/women's bathrooms/locker rooms will remain closed and the water bottle filling station will be turned off.
